The Vendor, and each individual employee agrees to abide by the Rules and Regulations as published by the Producer (Florida Pirate Festivals, LLC) and acknowledges that a violation thereof may void any contract with the Producer. Said rules and regulations are incorporated herein by reference and made a part hereof. All booths must be of Pirate/Medieval/Renaissance theme. All modern items must be masked and hidden. Vendor and all sales staff must be **appropriately costumed** (Pirate themed) during Festival hours, Renaissance acceptable.

All booths must be opened and manned during the Festival hours. At all times Vendor agrees to operate their business and any concessions granted hereby in a safety-first and always courteous manner. The Vendor further agrees to operate in every respect, in full compliance with all local, state, and federal law regulations.

The Vendor understands and agrees that during the course of the Festival, the Vendor might appear in photographs, videos, film, recordings and the like in connection with the Vendors participation in the Festival.

Vendor hereby consents to the use of any such audio, photo or video portrayal of the Vendor or the Vendors structure by the Producer for advertising, promotional, or any other purposes, and agrees that any such portrayals shall thereafter become the sole property of the Producer for their use thereafter. Vendor further agrees to comply with any reasonable request of the Producer for the Vendor to assist in the public relations activities of the Festival while on the Festival site.

Taxes:

Participants agree to pay all the necessary local, state and federal taxes from all earnings at the Florida Pirate Festival, to be invited back each year. The Producer (Florida Pirate Festivals, LLC) waives any responsibility thereof. All worker's Compensation Insurance is the liability of each and every Vendor.

Pets:

No pets are allowed on Festival site during the Festival hours of operation. If you have your pet on site during setup and tear down, please be courteous and clean up after your pet.

Fire Extinguishers:

Fire Extinguishers are required at each booth. The Fire inspector will be making random checks at each booth through the course of the weekend. Please have fire extinguishers present at all times.

Insurance:

All Food Vendors must supply a copy of their liability insurance in the amount of \$100,000 to the Florida Pirate Festivals LLC, naming the Florida Pirate Festivals, LLC as co-insured. Please supply a copy of your insurance with your application. If your insurance has not updated by Oct. 1st 2008, You must submit a copy of the current insurance for our records with your application showing you have insurance currently and submit a copy of the renewed insurance after renewal. Artisans without insurance may not participate in our Festival and will not receive a refund.

Cancellations:

Cancellations will be honored if received in written form before Oct. 1st, 2008. Cancellation by phone call or no-show will not be refundable. A \$50.00 processing fee will be deducted.

Drinking and smoking:

Consumption of Alcohol and or use of substance by participants during fair hours is prohibited. Smoking of cigarettes must be done discretely behind the scenes.

Please secure your valuable merchandise EACH EVENING. The Florida Pirate Festival, LLC is not responsible for the Theft of any Merchandise or Personal property left on the site.

Weather:

This is a rain or shine event. Weather conditions must not interfere with costuming or merchandising unless deemed unsafe by the Festival Management.

Set-Up:

Set-up will begin on November 19,2008. Please Check in prior to setting up your booth. All booths are required to be set up and vehicles off the grounds by 9:15 am on Festival days and must be opened for the duration of the show unless previously arranged through Management.

Electric:

Limited electrical usage spaces are available , these are awarded on a first come first serve basis .Please include the additional electrical fees along with your booth fees.

Booth Size:

Booth spaces are 12x12 .That includes 2 feet for tie downs. If your tent size is larger than 10 x 10, you must purchase additional footage at \$30.00 per foot. Contact the Vendor Coordinator if you have any additional questions or concerns.

Submitting Items for Jury:

Please fill out the included jury form for all food to be sold. Please supply the food item name, a description of the Item and any photos along with the form. While the Festival works diligently to Provide a venue where all of our vendors can thrive. No Vendor has Exclusive Agreements with the Florida Pirate Festivals, LLC.

Juried Items:

All Food items in each booth must be juried in. Only items approved by the director of Vendor Relations may be sold at the Florida Pirate Festival. Vendors found with items in their booth that are not on their APPROVED jury list will be asked to remove the unapproved items. If there is a second occurrence you will be asked to leave the site and you will not be refunded .

Overnight camping is permitted for recreational vehicles/trailers. To secure your campsite please complete the following form and return it to Florida Pirate Festival Vendor Relations . You will receive your camping Permit in your check- in package when you arrive.

Camping Information:

***Camping fee is \$100.00

*** Overnight Camping is available from Nov. 20 to Nov. 24, 2008

***Camping is allowed only in designated areas.

*** **All Vehicles must be off the grounds by 12:00pm on Monday the 24th**

***110v electric, showers and Port-a-lets are available. (you have to bring your own cord)

***RV hookups are **NOT** available.

*****No** Tent Camping.

***Recreation Vehicles may **NOT** release sewage content on the ground.

***Camp Fires are **NOT** permitted.

***Please keep loud noise, such as music, animals, and rowdy behavior to a minimum, **The city of St. Petersburg has a 10:00 pm noise ordinance which the local police and fair security will enforce.**

***Consumption of alcoholic beverages at anytime is not allowed.

***You will be responsible for cleanup and removal of all your trash.

***Pets are allowed only in camping area, the city of St. Petersburg has a leash law, Please make sure your pet is on a leash.

These rules have been created to make the camping site a safe and secure area for campers and their merchandise. Failure to comply with these rules may result in a vendor being asked to leave immediately, and may make vendors ineligible for admission to future shows. Florida Pirate Festivals LLC. reserves the right to make the final interpretation of the rules. Florida Pirate Festivals, LLC will supply security as a courtesy. The local police will also be patrolling the area.

COVENANT NOT TO SUE AND HOLD HARMLESS AGREEMENT

In consideration for receiving permission to participate in the 6th Annual Florida Pirate Festival, which is produced by Florida Pirate Festivals, LLC, Vendors shall release, waive, discharge, and covenant not to sue, and agree to indemnify and hold harmless Florida Pirate Festivals, LLC, each and every of its managing members, officers, directors, volunteers, sponsors, and agents and the City of St. Petersburg it's agents, employees officers, and volunteers from and against any and all loss, liability, expense, claim costs (including costs of defense), fines, penalties, consequences, and suits and damages of every kind, nature and description . Vendors shall pay all claims, damages, judgments, legal costs, adjustors' fees and attorneys' fees and attorneys' fees related thereto.

Vendors understand and appreciate the potential dangers, hazards, and/or risks, directly and/or indirectly inherent in participating in the Festival and its associated activities and events, which may include but are not limited to the loss of life, serious loss of limb, or loss of property. Vendors participation in the Festival and its associated activities and events is completely voluntary and at the Vendor's own risk. Vendors voluntarily assume full responsibility for any risks of loss, property damage or personal injury including death that may be sustained during or as a result of participation in the Festival and it's associated activities and events whether caused by an act of commission or omission on the part of the producers or otherwise.

It is the express intent of the Vendor that this covenant not to sue and hold harmless agreement shall bind the members of their family and spouse if alive and heirs, assigns and personal representatives if deceased.

In signing this covenant not to sue and hold harmless agreement I acknowledge and represent that I have read the foregoing covenant not to sue and hold harmless agreement, understand it, and sign it voluntarily as my own free act and deed; no oral representation, statements, or inducements apart from the fore going agreement that has been reduced to writing have been made. I execute this document for full, adequate and complete consideration fully intending to be bound by the same, now and in the future.
